Petitioner(s) and Respondent hereby enter into this Stipulation regarding the tax year 2013 valuation of the subject property, and jointly move the Board of Assessment Appeals to enter its order based on this Stipulation.

Petitioner(s) and Respondent agree and stipulate as follows:

1. The property subject to this Stipulation is described as:
1600 Prairie Center Parkway, Brighton, CO
Parcel: 0156915301022
2. The subject property is classified as commercial/medical property.
3. The County Assessor originally assigned the following actual value to the subject property for tax year 2013:

Land	\$ 7,466,438
Improvements	\$ 48,247,574
Total	\$ 55,714,012

4. After a timely appeal to the Board of Equalization, the Board of Equalization valued the subject property as follows:

Land	\$ 7,466,438
Improvements	\$ 48,247,574
Total	\$ 55,714,012

5. After further review and negotiation, Petitioner and County Board of Equalization agree to the following actual value for tax year 2013 for the subject property:

Land	\$ 7,466,438
Improvements	\$ 43,704,990
Total	\$ 51,171,428

6. The valuation, as established above, shall be binding only with respect to tax year 2013.

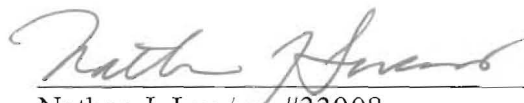
7. Brief narrative as to why the reduction was made: The total value of the property is \$51,171,428. Only 14% of which has been determined to be taxable, yielding a value of \$7,164,000.

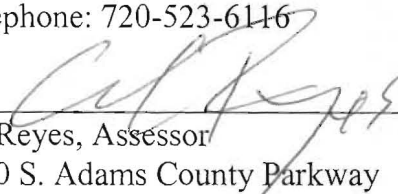
