FINAL AGENCY ORDER	

THIS MATTER was heard by the Board of Assessment Appeals ("Board") on December 10, 2020, Diane M. DeVries and Sondra W. Mercier presiding. Petitioner was represented by David M. McLain, Esq. of Higgins, Hopkins, McClain & Roswell, LLC. Respondent was represented by Christopher McMichael Esq., of the Adams County Attorney's Office. This appeal concerns the 2019 actual value of the subject property.

The subject property is owned by Petitioner, Brookfield Residential (Colorado) LLC. The subject consists of 343 single-family residential lots in the Brighton Crossing subdivision, located on the southwest corner of East 168th Avenue and North 60th Avenue, Brighton. The lots vary in size depending on filing and were at different levels of development on the assessment date of January 1, 2019.

The Adams County Board of Equalization ("CBOE") assigned a total value of \$25,250,524 to the lots, and Respondent requested at hearing that the Board sustain this value. The Petitioner asserted a value of \$10,817,523.

Following the hearing, on April 26, 2021, the Board issued an Interim Agency Order. The Board found that Petitioner succeeded in showing the subject property was incorrectly valued by the County for tax year 2019. The Board remanded the case to the County, and ordered the County to recalculate the value of the 343 lots using an individual lot value based on a UASP of \$65,000, a discount rate of 13%, and the absorption periods and percentage of development for each lot that had already been agreed upon by the parties. The Board provided the opportunity for Petitioner to object to the calculation.

The County provided a calculation of the value of the lots, and Petitioner objected to the calculation. Petitioner provided its own calculation of the lots' values, based on the Board's Interim Agency Order findings. The Board has reviewed the calculations and determines the County's calculation is incorrect, in that it did not follow the Board's directives, but that Petitioner's calculation is correct, and did follow the Board's directives. The Board finds that a new hearing is not necessary, as nothing remains to be decided. The Board made all of the factual and legal findings necessary at the April 26, 2021 hearing, and all that remained to be done to arrive at the value of the subject property were the mathematical calculations using the criteria provided by the Board in its Interim Agency Order.

The Board finds that the values of the lots for tax year 2019 total **\$11,075,775**. The petition is **GRANTED**. The Adams County Assessor's Office is ordered to update its records accordingly.

APPEAL RIGHTS

If the decision of the Board is against Petitioner, Petitioner may petition the Court of Appeals for judicial review according to the Colorado appellate rules and the provisions of Section 24-4-106(11), C.R.S. (commenced by the filing of a notice of appeal with the Court of Appeals within forty-nine days after the date of the service of the final order entered).

If the decision of the Board is against Respondent, Respondent, upon the recommendation 78669

of the Board that it either is a matter of statewide concern or has resulted in a significant decrease in the total valuation of the respondent county, may petition the Court of Appeals for judicial review according to the Colorado appellate rules and the provisions of Section 24-4-106(11), C.R.S. (commenced by the filing of a notice of appeal with the Court of Appeals within forty-nine days after the date of the service of the final order entered).

In addition, if the decision of the Board is against Respondent, Respondent may petition the Court of Appeals for judicial review of alleged procedural errors or errors of law within thirty days of such decision when Respondent alleges procedural errors or errors of law by the Board.

If the Board does not recommend its decision to be a matter of statewide concern or to have resulted in a significant decrease in the total valuation of the respondent county, Respondent may petition the Court of Appeals for judicial review of such questions within thirty days of such decision.

See § 39-8-108(2), C.R.S. (rights to appeal a tax protest petition); see also § 39-10-114.5(2), C.R.S. (rights to appeal on an abatement petition).
