Petitioner's request for withdrawal is granted; therefore, the Board will take no further action on this matter.

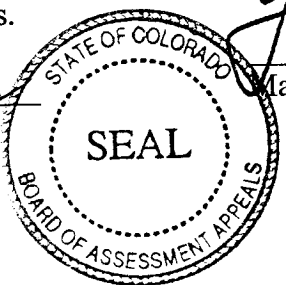

Please notify the ARAPAHOE COUNTY BOARD OF EQUALIZATION of the withdrawal of your appeal by sending them a copy of this letter.


