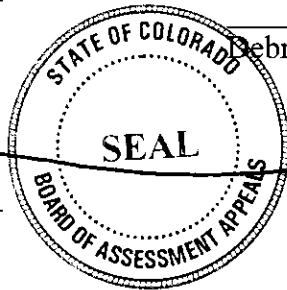

1. The property subject to this Stipulation is described as:

2. The subject property is classified as personal property.
3. The County Assessor originally assigned the following actual value to the subject property for tax year 2000: \$661,890.00.
4. After a timely appeal to the Board of Equalization, the Board of Equalization valued the subject property as follows: \$661,890.00.

5. After further review and negotiation, Petitioner and County Board of Equalization agree to the following tax year 2000 actual value for the subject property: \$654,880.00.


6. The valuation, as established above, shall be binding only with respect to tax year 2000.


7. Brief narrative as to why the reduction was made:


Walk-in coolers removed as Personal Property resulting in an actual value reduction of \$7,010.00.
