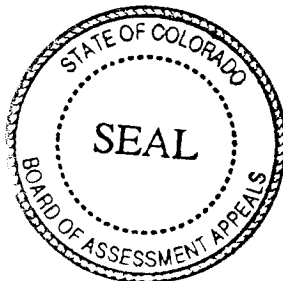


Petitioner and Respondent state, agree and stipulate as follows:

1. The above captioned proceeding is an appeal and protest of real property values as determined by the Larimer County Board of Equalization for certain real property located at Agilent's ("Agilent") R&D/office/manufacturing facility in Loveland, Colorado.
2. The subject properties are all improved real property.
3. Agilent's petition in appeal was timely filed and this Board has jurisdiction over the parties and the subject matter herein.
4. Attached as Attachment A is the actual value of Agilent's subject property, as assigned by the Larimer County Assessor for Tax Year 2000.
5. Attached as Attachment A-1 is the actual value of Agilent's subject property, as assigned by the Larimer County Board of Equalization for Tax Year 2000.

6. Based upon a further review of the complete asset lists of Agilent's real property, appraisal's and negotiation the Parties stipulate and agree that if competent and qualified witnesses were called to testify under oath, the actual value of Agilent's subject property is set forth on Attachment B.

8. The Board should enter an appropriate order setting the actual value of Agilent's real property for tax year 2000, in accord with the data set forth on Attachment B.


