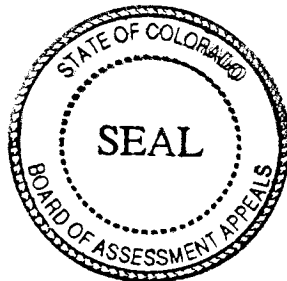

3. The County Assessor originally assigned the following actual value on the subject property for tax year 2000:

 Total	 \$13,500,000


6. The valuations, as established above, shall be binding only with respect to tax year 2000.


7. Brief narrative as to why the reduction was made:
