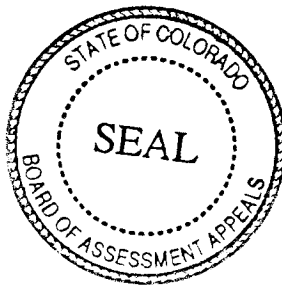



8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on May 23, 2001 at 1:00 p.m. be vacated.


