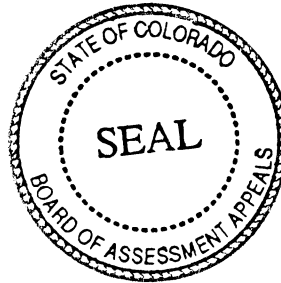

If you wish to go forward with hearing, no response is necessary. Thank you for your patience and cooperation in this matter.


