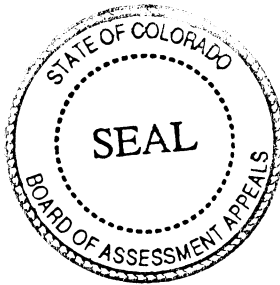

The Petitioner and the Board agree and stipulate as follows:
