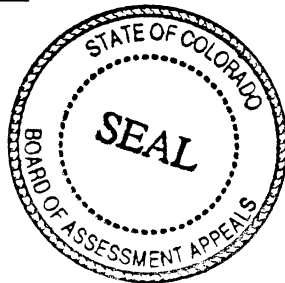

Reduction based on review of Market value, which indicates a lower value is warranted.


