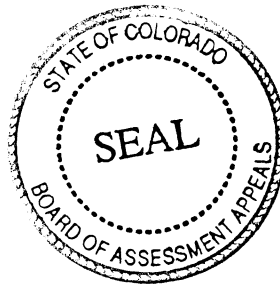

7. Brief narrative as to why the reduction was made:


Correction of the rentable area of the property.
