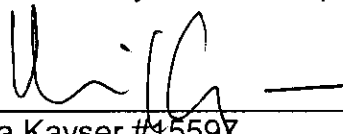
8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on August 8, 2003 at 8:30 a.m/ be vacated.
