Petitioner(s) and Respondent hereby enter into this Stipulation regarding the tax year 2001 valuation of the subject property, and jointly move the Board of Assessment Appeals to enter its order based on this Stipulation.

Petitioner(s) and Respondent agree and stipulate as follows:

1. The property subject to this Stipulation is described as follows: Westfield Village Shopping Center 9349 Sheridan Blvd. Westminster, Co. 80031

2. The subject property is classified as Commerical property. (what type).

3. The County Assessor originally assigned the following actual value to the subject property for tax year 2001:
