6. The valuations, as established above, shall be binding only with respect to tax year 2002.


7. Brief narrative as to why the reduction was made:

A reduction of value for the subject property was ordered by the Board of Assessment Appeals for tax year 2001. For tax year 2002 the data gathering period and the same factors apply.


8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on March 19, 2004 at 8:30 a.m. be vacated.
