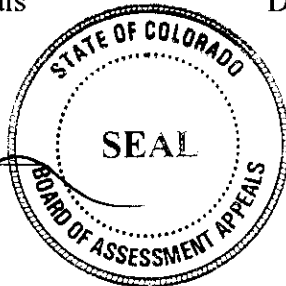

6. The valuations, as established above, shall be binding only with respect to tax year 2002.


7. Brief narrative as to why the reduction was made:

No further reduction, BOE value has been reviewed and supported.


8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on November 26, 2003 at 1:00 p.m. be vacated.
