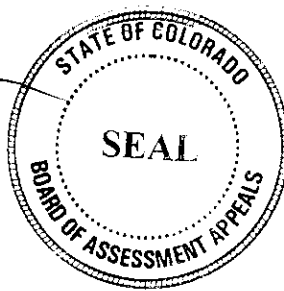

6. The valuations, as established above, shall be binding only with respect to tax year 2002.

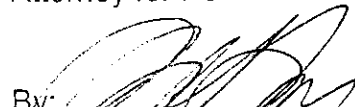
7. Brief narrative as to why the reduction was made:

Reconsideration of comparable market sales.

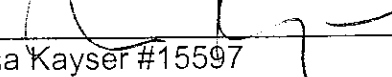
8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on December 15, 2003 at 3:00 p.m. be vacated.
