Respondent is ordered to reduce the 2002 actual value of the subject property, as set forth above.

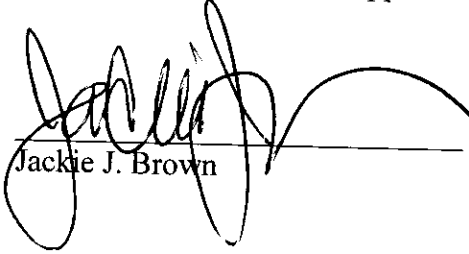

2. The subject property is classified as a possessory interest.

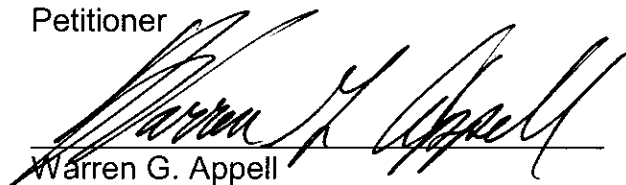
3. Attachment A reflects the actual values of the subject property, as assigned by the Assessor for tax years 2001 and 2002.

8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on February 24, 2004 at 8:30 a.m. be vacated.

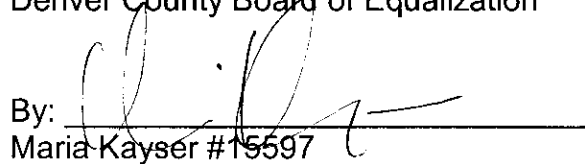
