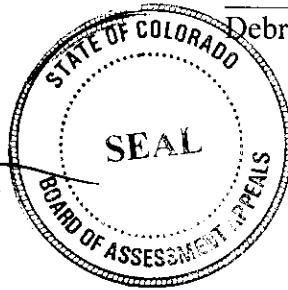

5. After further review and negotiation, Petitioner(s) and Board of County Commissioners agree to the following tax year 2001 actual value for the subject property:




6. The valuation, as established above, shall be binding only with respect to tax year 2001.
