Respondent is ordered to reduce the 2003 actual value of the subject property, as set forth above.



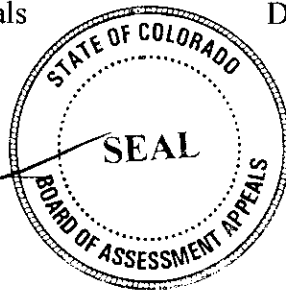



The Petitioner and the Board agree and stipulate as follows:

1. The property subject to this Stipulation is described as:

2. The subject property is classified as Residential.

3. The County Assessor assigned the following adjusted actual value to the subject property for tax year 2003:
