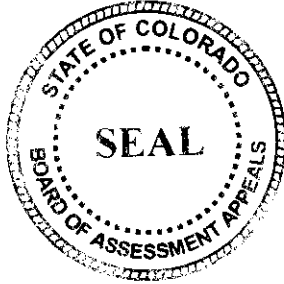

A brief narrative as to why the reduction was made: Analyzed market information and recognized impact of private road, bridge, access, Little Dry Creek and existing easements.


The parties have agreed that the 2003 actual value of the subject property should be reduced as follows:


