The Petitioner and Respondent agree and stipulate as follows:

1. The property subject to this Stipulation is described as:

Most of Lot 1, The Centre on Plum Creek Filing #2, 2nd Amendment. Total Acreage 1.428 AM/L.

2. The subject property is classified as Commercial property.

3. The County Assessor originally assigned the following actual value on the subject property for tax year 2003:

4. After a timely appeal to the Board of Equalization, the Board of Equalization valued the subject property as follows:

5. After further review and negotiation, the Petitioner and the Douglas County Board of Equalization agree to the following tax year 2003 actual value for the subject property:

Total	\$1,120,000


6. The valuations, as established above, shall be binding only with respect to tax year 2003.

7. Brief narrative as to why the reduction was made:


Information collected during site visit, in addition to independent appraisal submitted for review, supported an adjustment.
