The Denver County Assessor is directed to change his/her records accordingly.

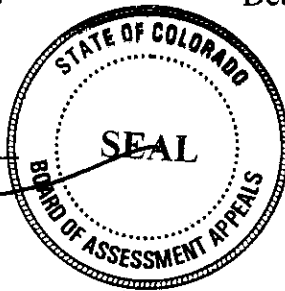



Additional consideration of sales of similar apartment buildings indicates a lower value for the subject property.


8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on June 1, 2004 at 3:00 p.m. be vacated.
