Respondent is ordered to reduce the 2003 actual value of the subject property, as set forth above.



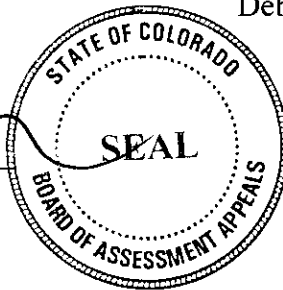

Petitioner(s) and Respondent hereby enter into this Stipulation regarding the tax year 2003 valuation of the subject property, and jointly move the Board of Assessment Appeals to enter its order based on this Stipulation.

Petitioner(s) and Respondent agree and stipulate as follows:

1. The property subject to this Stipulation is described as follows:
BLOCK 6 WHEATRIDGE HEIGHTS

2. The subject property is classified as residential property.

3. The County Assessor originally assigned the following actual value to the subject property for tax year 2003:

Land	\$ <u>116,230</u>
Improvements	\$ <u>114,000</u>
Total	\$ <u>230,230</u>

4. After a timely appeal to the Board of Equalization, the Board of Equalization valued the subject property as follows:

Land	\$ <u>116,230</u>
Improvements	\$ <u>105,270</u>
Total	\$ <u>221,500</u>

5. After further review and negotiation, Petitioner(s) and Board of Equalization agree to the following tax year 2003 actual value for the subject property:

Land	\$ <u>86,230</u>
Improvements	\$ <u>103,770</u>
Total	\$ <u>190,000</u>

6. The valuation, as established above, shall be binding only with respect to tax year 2003.

7. Brief narrative as to why the reduction was made:

CONSIDERATION GIVE FOR PROXIMITY OF I-70 HIGHWAY AND COMMERCIAL DEVELOPMENT. LAND HAS NO VIEW AND HALF OF LOT IS ON STEEP TERRAIN.
