6. The valuations, as established above, shall be binding only with respect to tax year 2003.

7. Brief narrative as to why the reduction was made:

An adjustment was made to the subject property value because of recognition of additional physical and functional obsolescence.

8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on July 5, 2005 at 3:00 p.m. be vacated.
