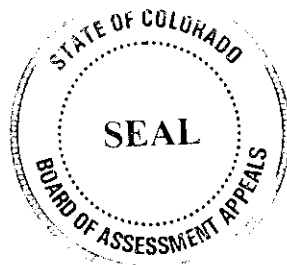

3. The County Assessor originally assigned the following actual value on the subject property for tax year 2003.

4. After appeal to the Denver County Board of Equalization, the Denver County Board of Equalization valued the subject property as follows:

5. After further review and negotiation, the Petitioner and Denver County Board of Equalization agree to the following actual value for the subject property for tax year 2003.

6. The valuations, as established above, shall be binding only with respect to tax year 2003.

7. Brief narrative as to why the reduction was made:

This hotel property was in transition from Sheraton Four Points to Best Western during the base period. The income was down during the base period while it re-established its position in the market. The temporary dip in income was recognized.


8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on February 28, 2005 at 1:00 p.m. be vacated.
