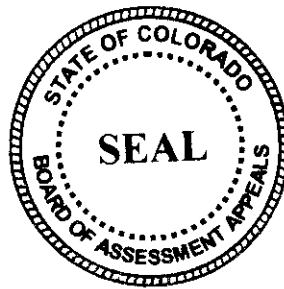

2. The subject property is classified as industrial property.

3. The County Assessor originally assigned the following actual value on the subject property for tax year 2003.

4. After appeal to the Denver County Board of Equalization, the Denver County Board of Equalization valued the subject property as follows:

Total	\$	990,400.00

5. After further review and negotiation, the Petitioner and Denver County Board of Equalization agree to the following actual value for the subject property for tax year 2003.

Land	\$	739,700.00
Improvements	\$	<u>210,300.00</u>
Total	\$	950,000.00

6. The valuations, as established above, shall be binding only with respect to tax year 2003.

7. Brief narrative as to why the reduction was made:

The reduction was made to reflect as close as possible the actual income and expenses for the property.

8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on August 15, 2005 at 1:00 p.m. be vacated.
