- 6. The valuation, as established above, shall be binding only with respect to tax year 2003.
- 7. Brief narrative as to why the reduction was made: The subject is deed restricted property. This property provides affordable living units to those meeting the 50% TO 60% income level requirements and is eligible for an economically derived market adjustment.
- 8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on October 20 at 1:00 PM be vacated.
- 9. This Agreement may be executed in any number of counterparts, each of which shall be deemed an original, and all of which shall constitute one and the same agreement.
