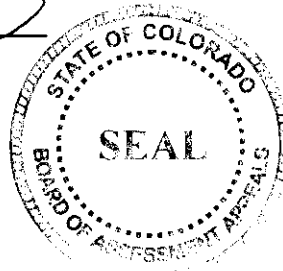

6. The valuations, as established above, shall be binding only with respect to tax year 2003.


7. Brief narrative as to why the reduction was made:

Market value established at \$95,000 per unit based on comparable sales analysis.


8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on December 15, 2005 at 1:00 p.m. be vacated.
