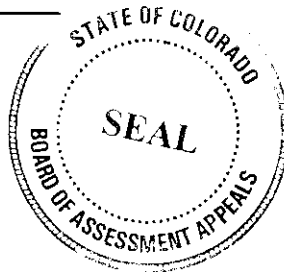

6. The valuations, as established on Attachment C, shall be binding with respect to only tax year 2003.


7. Brief narrative as to why the reduction was made:

A review of actual data on the property which was not available at an earlier time resulted in a reduction.


8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on March 28, 2006 at 8:30 a.m. be vacated.
