The Denver County Assessor is directed to change his/her records accordingly.

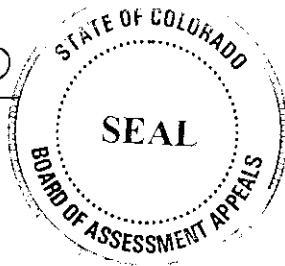

7. Brief narrative as to why the reduction was made:


Based upon operating data from the subject property, the income approach was adjusted.


8. A hearing has not been scheduled before the Board of Assessment Appeals.
