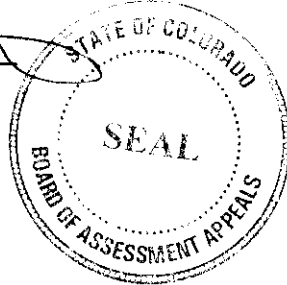

Allow for additional expenses to be consistent with 4190 Garfield St.


8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on April 25, 2006 at 8:30 a.m. be vacated.
