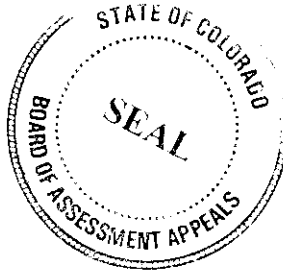

6. The valuations, as established above, shall be binding only with respect to tax year 2004.


7. Brief narrative as to why the reduction was made:

An adjustment was made to the subject property value for recognition of excess vacancy.


8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on April 28, 2006 at 8:30 a.m. be vacated.
