<b>STIPULATION (AS TO TAX YEAR 2004 ACTUAL VALUE)</b>	

Petitioner, BROOKFIELD REPUBLIC INC., and Respondent, DENVER COUNTY BOARD OF EQUALIZATION, hereby enters into this Stipulation regarding the tax year 2004 valuation of the subject property, and jointly move the Board of Assessment Appeals to enter its order based on this Stipulation.

6. The valuations, as established above, shall be binding only with respect to tax year 2004.

7. Brief narrative as to why the reduction was made:

A list of deferred maintenance items along with their cost was provided by the petitioner. After deduction of the reserve already allowed in the income approach, the remaining \$1,844,400 is deducted from the assigned value.


8. A hearing has not been scheduled before the Board of Assessment Appeals.
