Respondent is ordered to reduce the 2004 actual value of the subject property, as set forth above.





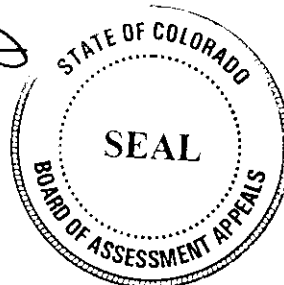

5. After further review and negotiation, Petitioner(s) and County Board of Equalization agree to the following actual value for tax year 2004 for the subject property:



6. The valuation, as established above, shall be binding only with respect to tax year 2004.


7. Brief narrative as to why the reduction was made: Reduction to market value.
