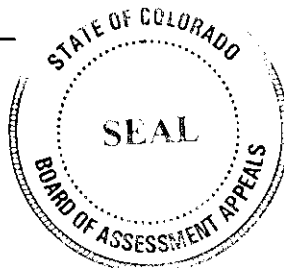

The Petitioner and Respondent agree and stipulate as follows:

1. The property subject to this Stipulation is described as:

Tract in NW ¼ NW ¼ 14-8-67 and SW ¼ SW ¼ 11-8-67 fronting east row
line of Interstate 25, 1.55 AM/L

2. The subject property is classified as Vacant Land property.

3. The County Assessor originally assigned the following actual value on the subject property for tax year 2004:
