STIPULATION (AS TO TAX YEAR 2003 AND 2004 ACTUAL VALUE)	

Petitioner, PLATTE STREET BUILDING CORP, and Respondent, DENVER COUNTY BOARD OF EQUALIZATION, hereby enters into this Stipulation regarding the tax years 2003 and 2004 valuation of the subject property, and jointly move the Board of Assessment Appeals to enter its order based on this Stipulation.

The Petitioner(s) and Respondent agree and stipulate as follows:

1. The property subject to this Stipulation is described as:
 A restaurant/office building located at 2373 to 2375 15th Street
 Denver, Colorado 80202
2. The subject property is classified as commercial property.

3. The County Assessor originally assigned the following actual value on the subject property for tax years 2003 and 2004.

4. After appeal to the Denver County Board of Equalization, the Denver County Board of Equalization valued the subject property as follows:

5. After further review and negotiation, the Petitioner and Denver County Board of Equalization agree to the following actual value for the subject property for tax years 2003 and 2004.

6. The valuations, as established above, shall be binding only with respect to tax years 2003 and 2004.

7. Brief narrative as to why the reduction was made:

A compromise was made and agreed upon to adjust for excess vacancy by reducing the assigned land value.

8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on June 13, 2006 at 1:00 p.m. be vacated.
