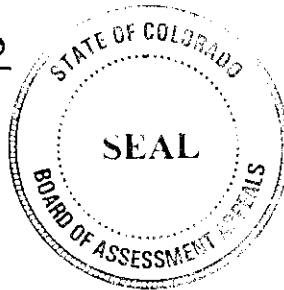

6. The valuations, as established above, shall be binding only with respect to tax year 2003.


7. Brief narrative as to why the reduction was made:

Market value established at \$70,800 per unit / \$99.00 per gross square foot based on comparable sales analysis.


8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on August 18, 2006 at 8:30 a.m. be vacated.
