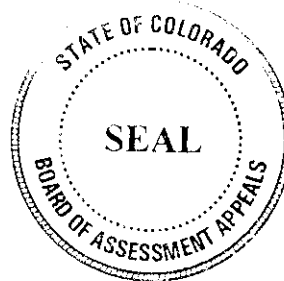


Reduction is granted due to negotiation between County Attorney's Office and the taxpayer.
