The Petitioner and Respondent agree and stipulate as follows:

1. The property subject to this Stipulation is described as:

Lot 72 Castle Pines Village #8-B, 0.355 AM/L

2. The subject property is classified as Residential property.

3. The County Assessor originally assigned the following actual value on the subject property for tax year 2005:

Land	\$198,950
Improvements	\$501,050
Total	\$700,000

4. After a timely appeal to the Board of Equalization, the Board of Equalization valued the subject property as follows:

Land	\$198,950
Improvements	\$501,050
Total	\$700,000

5. After further review and negotiation, the Petitioner and the Douglas County Board of Equalization agree to the following tax year 2005 actual value for the subject property:

Land	\$198,950
Improvements	\$451,050
Total	\$650,000


6. The valuations, as established above, shall be binding only with respect to tax year 2005.

7. Brief narrative as to why the reduction was made:


Further review of the sales comparison approach and consideration of the actual purchase price of the subject property warranted a reduction in value.
