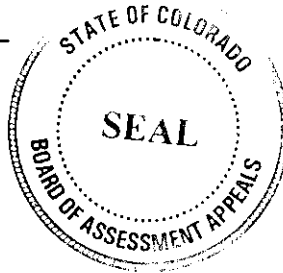

Petitioner(s) and Respondent hereby enter into this Stipulation regarding the tax year 2005 valuation of the subject property, and jointly move the Board of Assessment Appeals to enter its order based on this Stipulation.

Petitioner(s) and Respondent agree and stipulate as follows:

1. The property subject to this Stipulation is described as:
 12596 Home Farm Drive, Westminster, Adams County, Colorado
2. The subject property is classified as residential property.
3. The County Assessor originally assigned the following actual value to the subject property for tax year 2005:

Land	\$ 75,000
Improvements	\$ 279,015
Total	\$ 354,015

4. After a timely appeal to the Board of Equalization, the Board of Equalization valued the subject property as follows:

Land	\$ 75,000
Improvements	\$ 279,015

5. After further review and negotiation, Petitioner(s) and County Board of Equalization agree to the following actual value for tax year 2005 for the subject property:

6. The valuation, as established above, shall be binding only with respect to tax year 2005.


7. Brief narrative as to why the reduction was made: Reduction to market value. Subject property sold 3-25-05 for \$312,500. Subject property was appraised at time of sale at \$324,000.

8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on June 8, 2006, at 10:30a.m. be vacated.


