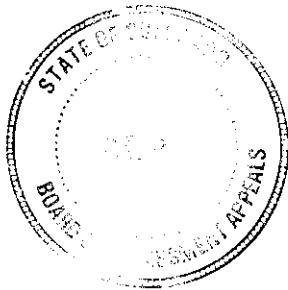

7. Brief narrative as to why the reduction was made:


After further review based on additional information provided by the petitioner, the 2005 actual market value was reduced.


