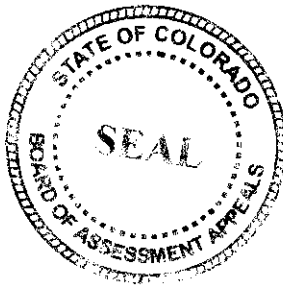

A brief narrative as to why the reduction was made: Analyzed Cost, Market, and Income Information.




