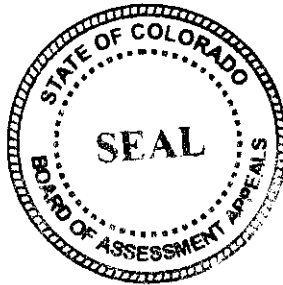

Subject property is classified as single family residence and described as follows: 9 Wildrose Trl: County Schedule # 2077-01-2-11-004; RA2461-041.






