4. After appeal to the Denver County Board of Commissioners, the Denver County Board of Commissioners valued the subject property as follows:

7. Brief narrative as to why the reduction was made:

The property was uninhabitable much of the year. The problem arose from the petitioner's unfamiliarity with the appeals process. The petitioner waited until receiving the 2004 tax notice before appealing.

8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on August 2, 2006 at 10:30 a.m. be vacated.
