6. The valuations, as established above, shall be binding only with respect to tax year 2005.


7. Brief narrative as to why the reduction was made:

Consideration of additional sales appropriate to the subject property indicated a reduction in value was warranted.


8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on November 2, 2006 at 10:30 a.m. be vacated.
