<b>STIPULATION (AS TO TAX YEAR 2005 ACTUAL VALUE)</b>	

Petitioner, JAMES F. HEIMBECHER, and Respondent, DENVER COUNTY BOARD OF EQUALIZATION, hereby enters into this Stipulation regarding the tax year 2005 valuation of the subject property, and jointly move the Board of Assessment Appeals to enter its order based on this Stipulation.

The Petitioner(s) and Respondent agree and stipulate as follows:

1. The property subject to this Stipulation is described as:  
  
 Lots 6 EXC S 18FT Thereof & L 7&8 BLK 1 Kennedys Add to the Town of Denver, Colorado
2. The subject property is classified as residential property.
3. The County Assessor originally assigned the following actual value on the subject property for tax year 2005.

Land	\$	358,600.00
Improvements	\$	<u>2,000.00</u>
Total	\$	360,600.00

4. After appeal to the Denver County Board of Equalization, the Denver County Board of Equalization valued the subject property as follows:

Land	\$	322,700.00
Improvements	\$	<u>4,700.00</u>
Total	\$	327,400.00

5. After further review and negotiation, the Petitioner and Denver County Board of Equalization agree to the following actual value for the subject property for tax year 2005.

Land	\$	238,600.00
Improvements	\$	<u>2,000.00</u>
Total	\$	240,600.00

6. The valuations, as established above, shall be binding only with respect to tax year 2005.

7. Brief narrative as to why the reduction was made:

Consideration of additional sales appropriate to the subject property indicated a reduction in value was warranted.

8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on October 26, 2006 at 4:00 p.m. be vacated.
