6. The valuations, as established above, shall be binding only with respect to tax years 2005-2006.

7. Brief narrative as to why the reduction was made:

The recognition of physical condition issues, including a leaking roof system, supports the downward adjustment.

8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on March 30, 2007 at 8:30am be vacated.
