7. Brief narrative as to why the reduction was made:


The value was adjusted based upon information contained in the subject's base period rent roll and operating statement which was recently made available.


8. Both parties agree that the hearing scheduled before the Board of Assessment Appeals on May 9, 2008 at 8:30 AM be vacated.
