Respondent is ordered to reduce the 2005 actual value of the subject property, as set forth above.



3. The parties agree that the 2005 actual values of the subject property shall be Stipulated Values below:

6. This valuation is for purposes of settlement only and does not reflect an appraised value.
7. Petitioner(s) agree(s) to waive the right to a Board of Assessment Appeals hearing and any further appeal of schedule number: **094446** for the assessment year(s) covered by this Stipulation.
