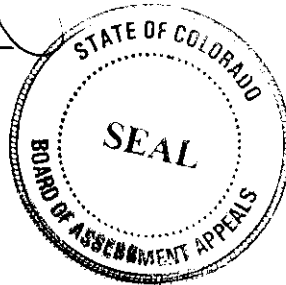

7. Petitioner(s) agree(s) to waive the right to a Board of Assessment Appeals hearing and any further appeal of schedule number: **140526** for the assessment year(s) covered by this Stipulation.
